G ender Sensitive Initiatives is a national NGO registered in 1993, concerned with different disadvantaged groups in society such as children, women and people with disabilities. It believes that poverty reduce peoples capacity to the full utilization of their resources. GSI has programs on population and family planning awareness, primary health promotion and on poverty and the youth.

Poverty is one of the causes of land rights violations and the GSI is particularly concerned with poor women's lack of access to land. Women do not own land, yet they are the ones who utilize it. Poor land productivity, food production and lack of family security are issues which will not be resolved as long as women are denied the right to land.

The management of land under wildlife usage is a major concern of GSI, because the inhabitants of wildlife reserve areas and their rights in terms of the land are interfered with. The GSI is also concerned with environmental issues as it relates to land such as desertification of land due to cutting down of mature trees and the use of pesticides and chemicals in the coffee and tea areas.

The Kenya Human Rights Commission (KHRC) was formed in 1992 and is an advocacy and monitoring organization. The mission of the KHRC is to protect, monitor and promote the enjoyment of internationally recognized human rights in Kenya. KHRC monitors the human rights situation in Kenya, publishes reports, briefs, journals and other written materials on various issues to create public awareness.

The Land Rights project of the KHRC was started in 1995. Through this project the KHRC advocates on behalf of individuals and communities in matters regarding land rights issues. It aims at articulating the problem of land in Kenya today.

The project work includes monitoring and researching issues related to land rights and their impact on society and advocating for people oriented land policies. The project hopes to deal with questions related to land ownership in Kenya in terms of what percentage is foreign, local, individual and communally owned; the proportion of landless people in Kenya and the usage of land for tourist, agricultural and pastoral purposes. Up to date, the project has carried out research on land clashes, land abuse, grabbing and corruption in land and its impact on development; women and land issues and the question of squatters, slum dwellers and marginalized people. The National Council of Non-Governmental Organizations of Kenya (NGO Council) is a collective forum for registered NGOs. It was launched in April 1993 and is an independent, nonpartisan, self-regulatory organ of member NGOs. Organizations do not apply for membership directly to the council, it is automatic upon registration under the provisions of the Section 23 (1) of the NGO Act.

The NGOs Council deals with land rights issues together with Kituo cha Sheria, KHRC and the *Mazingira Institute* through *Operation Firimbi*. Operation Firimbi's aim is to gather information and promote civic education for ensuring commitment to the rule of law, just governance and protection of the management of public lands. Through this network, the NGOs Council seeks to sensitize the public on issues regarding land rights, ownership, public utility land and private property land.

On an average, the NGOs Council receives ten reports per day from all over the country, the majority from areas such as Kilifi, Kiambu, Diani and Kwale. Information on public land grabbing is communicated to *Operation Firimbi* through the **Fax hot**-

lines (Nairobi): 568445, 712414, 444643, 574997, 553860 or through P.O. Box 48278, 7483 or 14550 Nairobi. Once the information is received, Operation Firimbi organizes advocacy, media exposure and aid in mobilizing the residents for effective action on the issue. For legal assistance, clients are referred to Kituo cha Sheria.

The NCCK is a non-profit advocacy umbrella group of protestant churches in Kenya. The organisation has over three hundred projects all over the country, dealing with socioeconomic issues.

Under the Human Rights Awareness Project, the NCCK deals with cases concerning land rights. It has an office in Eldoret which deals with land rights abuses and land clashes. NCCK assists squatters, refugees, internally displaced people and land clash victims by providing shelter, food, medical and assists in seeking resettlement. Resettlement programmes have been established in Uasin-Gishu and Nandi districts. Other initiatives are based in Turkana for landless children and refugees where they assist their clients with formal education to promote self-independence.

NCCK provides legal assistance to their clients in land rights issues especially in Burnt Forest area, Western Kenya and Rift Valley. They have also managed to fund-raise to be able to purchase land for some communities. The NCCK publishes a monthly bulletin " Clashes update "highlighting abuses of land rights.

The Release Political Prisoners is a pressure group, which was formed in 1991, with the objective of working towards the release of all political prisoners. However, its activities are not limited to this since it believes that as long as there is unjust distribution of resources and continued violations of peoples' rights, everyone is a prisoner whether on the inside or the outside of an individual jail.

RPP addresses the issue of land rights through organizing, mobilizing and advocacy. The group supports communities who are being evicted by organizing them around their demands and by facilitating legal and medical aid when they are arrested and brutalised by the police. The RPP has been and is involved in the communities of Soweto-Spring Valley, Kibera and Korogocho among others.

Other activities involve the organizing of cultural activities to raise awareness on various issues, workshops and the production of a newsletter called Mtetezi.

The Social Development Network (SODNET) was launched in July 1994 under the name of KINGA. It is an advocacy group and serves as a communication network, which lobbies together with other NGO's on issues related to social policy development, research, communication and information exchange.

The organization has participated in workshops and seminars dealing with the most critical stake-holders such as clash victims, pastoralists communities, urban slum dwellers, evicted squatters etc. It has also initiated a sustainable Peace and Reconciliation process aimed at building new and durable bridges between state sector, civic society, business and other sub sectors.

SODNET's main programme activity is electronic networking aimed at influencing policies and create a forum with member NGO's to discuss and create awareness on issues regarding environmental, civic, legal and human rights as it relates to social development. Federation of International Women Lawyers (FIDA) is a membership organization which was formed in 1986. It is a non-profit, nonpartisan NGO based in Nairobi. The organization aims at enhancing the status of women through legal awareness, legal aid and lobbying for law reform.

Women's lack of access to land is due to the general lack of knowledge of their rights and the existing laws. Through advocacy, lobbying for law reform, in particular the Succession Act, the Married Women's Property Act and the Matrimonial clauses and legal aid, FIDA advocates for women's land rights.

The organization has several committees dealing with women's property rights, democratization and gender violence, displaced women, the girl-child, reproductive rights etc. The committee on women's property rights studies laws related to women's property rights and has made recommendations to the task force on laws related to women. They also produced the client guide for FIDA.

Kituo cha Sheria is a legal aid centre which provides legal aid and advice to those who can not afford legal costs. Kituo also publishes legal education materials aiding in enhancing legal literacy in the country.

Land rights issues are a major concern for Kituo. Many of their clients report cases related to inheritance or eviction by land grabbers. Another important aspect of Kituo's work is to network with other groups to lobby for constitutional changes regarding the Land Law.

Kituo provides services at a national level, for those who can not afford to travel to Nairobi. One of their focus area outside Nairobi is the coastal region, specifically with the people of Majaoni. In this area land grabbers attempted to evict a group of Mijikenda farmers who had formed a cooperative society known as Majaoni at Mtwapa Creek. Kituo represented their case in court. Involvement in this case lead to the bombing of the former offices. Currently, Kituo is involved with the evictions of the people in Soweto shun village at Spring Valley among others.

Legal Resources Foundation (LRF) was formed in 1994 as a Legal Resources Foundation (LRF) was formed in 1994 as a result of public outcry against violations of land rights and the need for communities to come together and collectively organise against these violations.

Such violations include land grabbing within urban areas of public and private utilities land, evictions of squatters, non-maintenance and neglect of the present public lands. As a result of these issues, there was a need to educate and advocate for the protection of both land rights and human rights as they are closely interlinked.

The organization assists in organizing training sessions, workshops and provides legal advice. LRF has organized public rights awareness programmes in schools and colleges. It has also used drama as a means to raise awareness on human rights issues. LRF have published manuals from workshops and posters to educate the public on various issues such as human rights, women's rights etc.

On land rights, the PLI completed a research project on control of trust lands where a lot of land had been alienated to politically connected individuals, groups and companies against the interests of persons ordinarily resident on Trust lands. Through Operation Firimbi, PLI works with other NGO's such as Kituo Cha Sheria and KHRC to advocate against the grabbing of public trust land.

Mr. Lenaoola has represented individual cases in court, public awareness on land rights cases through NGOs, groups and workshops in the pastoralists districts.

Mr. Lenaoola is also a consultant with NGOs such as Research & Training Consultants Co Ltd, now operating in 10 pastoralists districts to recover the semi-arid and arid lands. He translates the land rights laws into local languages (Maasai) so that they can understand the land rights laws well and in order to provide easy access to the law. He coordinates workshops and seminars to educate people living in nomadic/pastoralists lands on land rights awareness. Working together with NGOs such as the Nomadic Pastoralists Peoples Organization, Mr. Lenaoola facilitates general awareness of land rights and in creating a working programme that will minimize future land disputes.
